Instruments for the definition, boost and govern the IMP

- **2030 Maritime Strategy of Catalonia (Planning of the IMP)** { Initiatives, projects (**CLLD**, others) - Implementation
- **Maritime Co-management Council (Governance of the 2030MSC, co-definition of the IMP)** { 2022-2025 Strategic Plan of the 2030 MSC
Other initiatives
- **MSP (Spatial Planning)** { Planning tools for the uses of the maritime space (protection, conservation, restauration, concessions, etc.)
- **ICATMAR (Governance support through research)** { Scientific advice for governance
- **Other governance Instruments** { Co-management committees (fisheries) and territorial maritime co-management groups

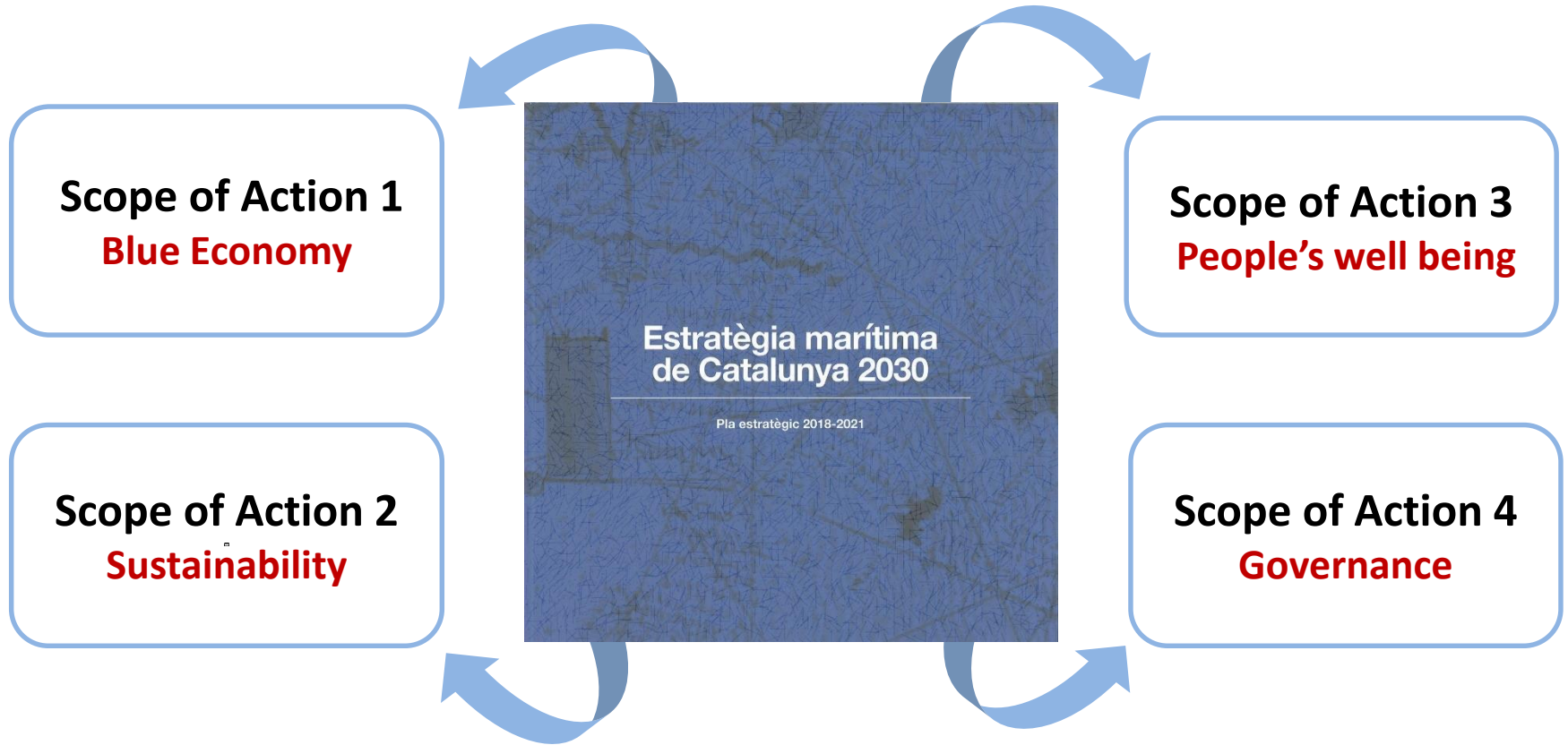

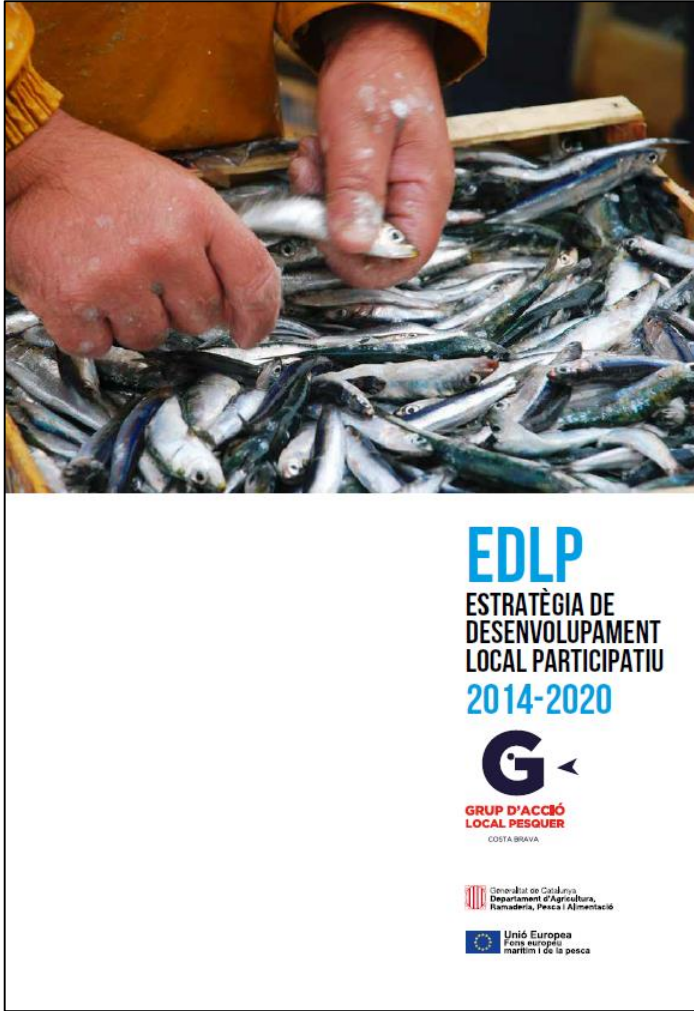

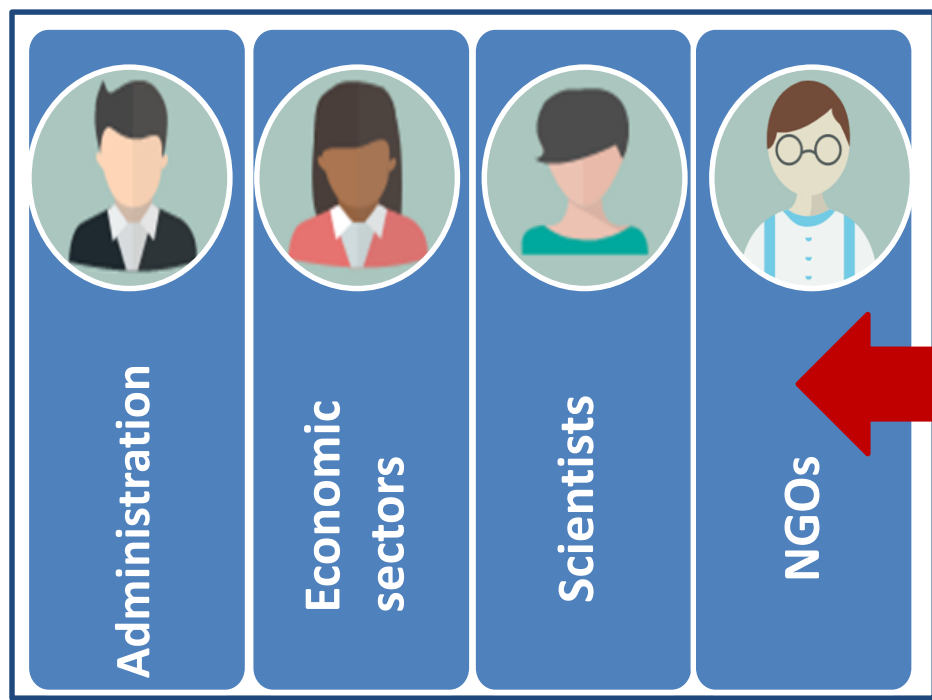
Outcome of the current Strategic Period

- Current **FLAGs**, have proven to be the best vehicle for territorial implementation of the **2030 Maritime Strategy of Catalonia** through their CLLD strategies by boosting the local economy through joint projects among different players from the fishing and maritime territory
- Since 2018, a total of **141 projects** have been funded for a value of **€ 3.3 M**, for the promotion of new business opportunities, social inclusion and the protection and creation of jobs in the field of the Blue Economy
- At the same time, within the framework of the **2030 MSC**, various actions have also been carried out aimed at strengthening and supporting the existing FLAGs and preparing the conditions for setting up new ones in those territories that still don't have a FLAG

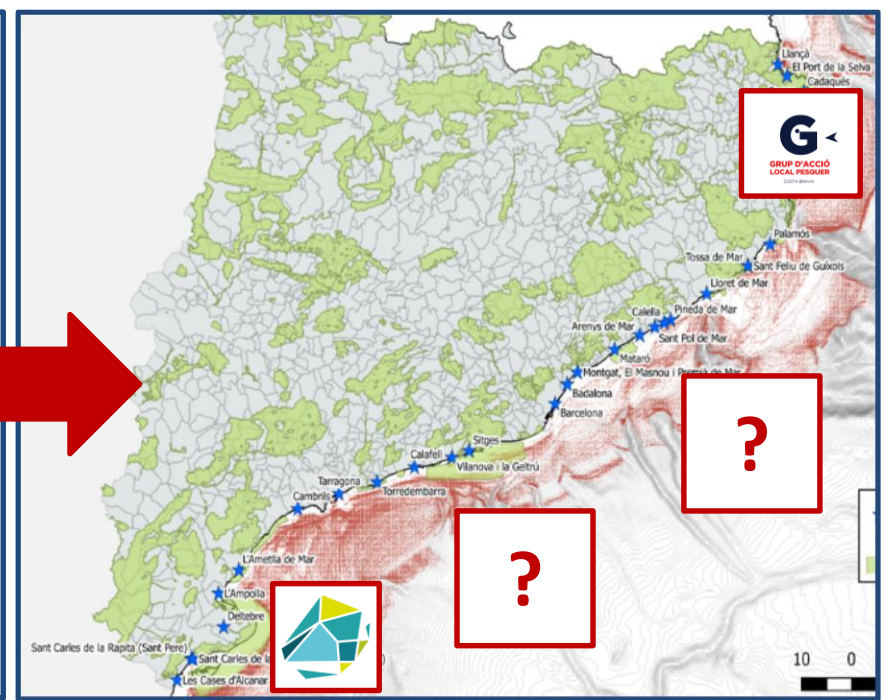

Four FLAGS

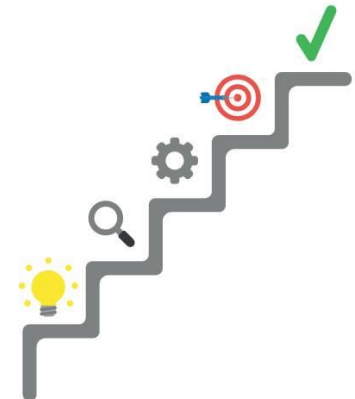


Objective 2021 – 2027

Export the successful initiatives of the current two GALPs to the rest of the Catalonian coast in order to have a GALP network along the whole coast

Next Steps

- **2021-2022:** cooperation project between the current 2 FLAGs and the Catalan Federation of Fishermen's Guilds to carry out the public participation process to design the future CLLD Strategies
- Increase the current budget for FLAGs in the next FEMP call
- New BE indicators to score the proposals
- Expand the network of local actors with new partners
- Strengthen the role of the FLAGs in the implementation of the 2030MSC
- Adapt the current CLLD Strategies to the challenges of the 2021-2027 period
- Complement FEMP/FEMPA with own budget (Climate Fund)



CLLD: objectives and challenges period 2021-2027

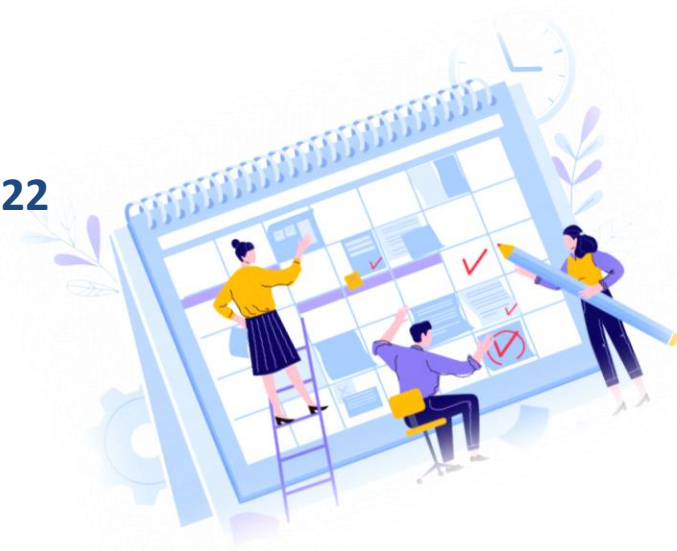
CLLD should focus on ensuring that fishing communities benefit from the Strategy by promoting:

1. Cooperation project between the current 2 FLAGs → 2021-2022
2. Participative process in the territory → 2021-2022
3. Approval of the Operational Programme → End of 2022
4. Presentation of new proposals → 2022-2023
5. Elaboration of the CLLD → 2023
6. Selection of the new FLAGs → 2023
7. Signature of the Cooperation Agreements with the DACC → end of 2023
8. FLAGs call → 2024

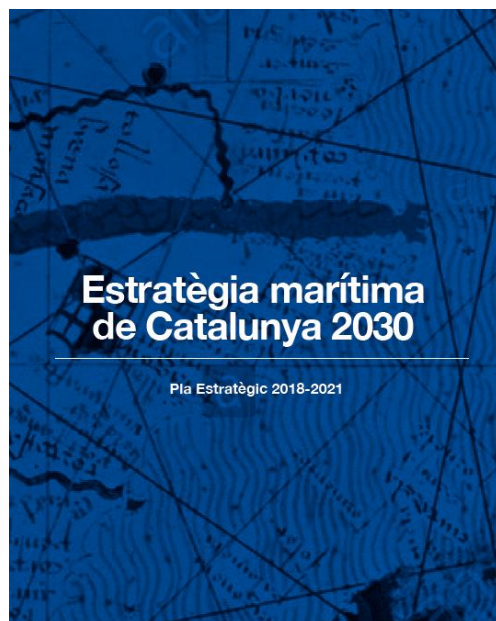
