INNOVATIVE PROCESS

Strengthen the networks between operators and supply chain networks inside and outside the Emilia-Romagna coastal area

This **bottom-up approach** followed (making public consultations of local stakeholders, identifying relevant experts for participating in FLAG's Working Groups, etc.) is new in the region, and it was managed by the FLAG itself. Actually, a representative of the national Ministry of Fisheries was present at the launch of the Working Group for learning more about this methodology, that could potentially being implemented in other regions.

Improvement of policies and programs' implementation in Em.Rom. Region and in other coastal areas

This approach can be easily transferred in every theme where gathering local knowledge is an added value. For ensuring the better implementation of this inclusive approach, a well-connected community is required, as well as the different stakeholders' involvement. The FLAG plays an essential role in coordinating all activities and all stakeholders. This was possible because of the FLAG's experience as animator of the whole regional area

Regional and national recognition for the actions conducted by the FLAG

The MA (National) and the IB (Region) supported the FLAG actions and are now considering adopting the FLAG's governance approach to develop new Action Plans for solving issues linked to coastal fisheries

The small-scale coastal fisheries management plan will influence the regional and national policies and the guidelines will be used in national programme
